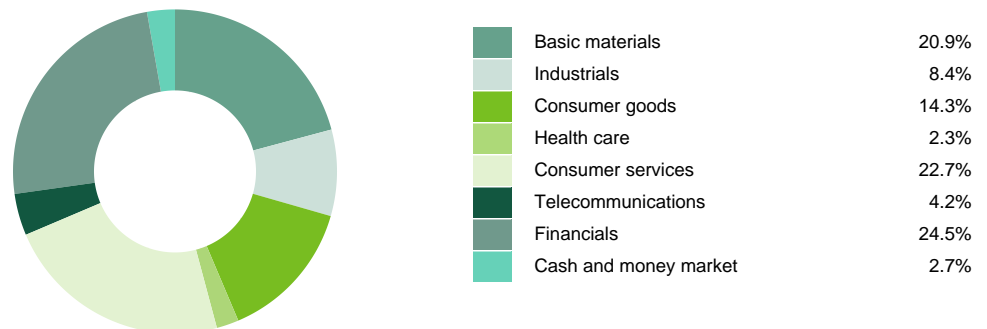

Portfolio attributes

- This is a domestic general equity fund targeting maximum capital appreciation over the long term
- The fund may invest across all industry groups as well as a range of large, mid and smaller cap shares in South Africa.
- In managing the portfolio the manager constantly monitors relative performance and in particular that of liquid, large market cap shares and trades actively at the margin
- At least 80% of the portfolio will be invested in equities at all times and currently the portfolio does not include any direct offshore investment.

Investment manager

- Abax Investments is an independent, owner-operated investment firm founded in 2003.
- AMG, a global asset management company with interests in leading fund management boutiques around the world, owns 25%, with the remaining 75% owned by employees and 3 charitable trusts
- Abax Investments is dedicated exclusively to fund management across a focused range of equity, multi-asset and fixed income portfolios
- Abax Investments have managed the Nedgroup Investments Rainmaker Fund since inception (with the principal portfolio managers later founding Abax in 2003)

Investment philosophy

- Abax Investments believe in bottom-up, fundamental research, stock picking
- They focus on: Earnings growth as the primary driver of share price appreciation; quality and price paid to protect the downside and capture as much of the upside as possible and; a concentrated core of shares offering relatively high growth at relatively attractive valuations
- They are aware of the benchmark composition, but construct portfolios purely on the basis of the investment merit of companies and their level of conviction
- They incorporate macroeconomic and industry views into their share and portfolio construction discussions to inform a top-down perspective but the investment decision is driven primarily by the bottom-up analysis
