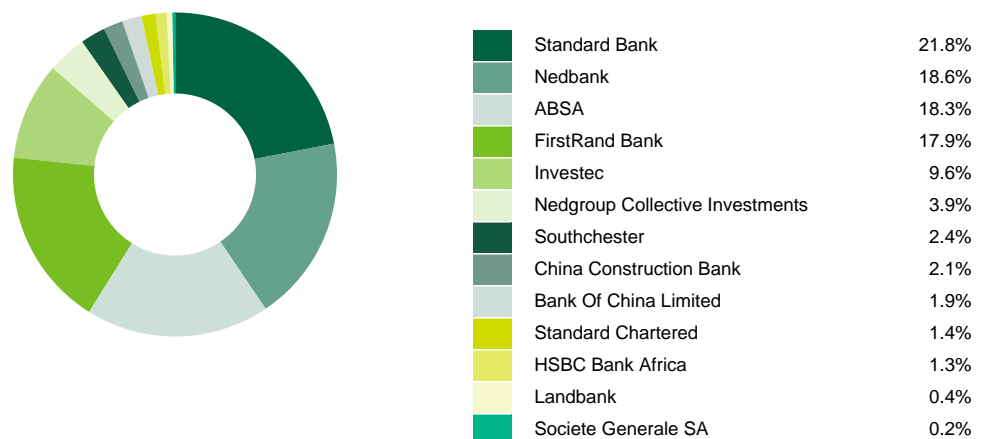

Portfolio attributes

The investment process is built on the premise of capital preservation from which all key risk drivers are managed to achieve the Nedgroup Investments Core Income Fund's object through different investment cycles. The investment manager will endeavour to unlock the liquidity risk premium embedded in money market assets via the structuring and purchasing of assets that will create yield enhancement over the life of the asset within the fund.
