Market Commentary

The first half of 2025 has been defined by heightened geopolitical tensions, evolving trade dynamics, and a gradual rebalancing of global economic leadership. While President Trump's declaration that "the golden age of America begins right now" was followed by a surge in market optimism, that initial euphoria faded in Q2 amid rising investor caution. Concerns over policy-driven growth, escalating tariffs, and global instability have since weighed on sentiment, challenging the narrative of continued American exceptionalism.

Trade tensions have dominated headlines, with the US implementing a series of tariffs. By the end of June, the average effective tariff rate on US imports had climbed to 15.8%. Investors remain wary of the inflationary impact of these measures, with Fed Chair Powell noting that the effects are likely to appear in CPI data over the summer. While higher inflation could support corporate earnings by allowing firms to pass on costs, it also adds to market uncertainty.

Despite these headwinds, global equity markets have shown resilience, climbing to record highs in Q2. The US dollar has weakened significantly—down over 10% year-to-date—creating room for monetary easing in Asia. Central banks in Hong Kong, Singapore, and across the region have taken advantage of this window, laying the groundwork for a new phase of growth and financial market development in Asia.

In Europe, geopolitical shifts and a more assertive Russia have prompted a renewed focus on defence. Germany's approval of unlimited defence spending and a €500bn infrastructure fund has been seen as a turning point, potentially ushering in a new era of European collective security and economic stimulus.

Meanwhile, market sentiment remains fragile. The military conflict between India and Pakistan, and the unprecedented direct confrontation between Israel and Iran, have added to global unease. Yet, in the absence of a sharp deterioration in economic data, diversified portfolios have performed well, benefiting from a rotation away from the concentrated momentum trades that dominated 2024.

Looking ahead, investors are likely to remain in a "wait-and-see" mode. The trajectory of inflation, the durability of corporate earnings, and the evolving trade landscape will be key drivers of market direction. While volatility is expected to persist, the first half of 2025 has shown that diversification and global exposure remain effective strategies in navigating an increasingly complex investment environment.

Performance

The aim of the strategy is to provide a stable stream of real total returns over the long term with low absolute volatility and significant downside protection.

The portfolio delivered positive absolute returns over the first half of 2025, with performance driven by allocations to both U.S. and non-U.S. equities and bonds. The currency hedging program, which aims to protect the portfolio by hedging out exposure to overvalued currencies relative to US Dollar, detracted in the second quarter as the US Dollar depreciated against the Australian dollar. The US Dollar remains under selling pressure amid mounting US debt concerns, and US government policies. A reversal in equity market leadership saw non-U.S. equities—represented by the MSCI World ex USA—outperform U.S. equities, led by strong performance in European and Japanese markets. While non-U.S. equity holdings in the portfolio posted solid gains, they lagged the broader benchmark. U.S. equity allocations outperformed their respective index, contributing positively.

Both U.S. and non-U.S. bond exposures added value, benefitting from the short duration positioning, outperforming their respective benchmarks over the period. The US Treasury yield curve steepened over the second quarter after The Reconciliation Bill increased concerns over US debt. In the UK, long-dated yields remained high also reflecting growing concerns over debt levels, budget deficits, and decreasing investor confidence in the government's fiscal plans.

North American equity markets were up over the 6 months. In the US, the stock market had one of its most volatile periods in recent history. At the beginning of the second quarter, the market fell by nearly 20% as tariffs were introduced by the US administration and investors became extremely concerned about the effect on global growth. This caused declines in stock and bond prices which eventually led to the US administration suspending tariffs and this initiated a reaction rally in the US stock market. Having been down nearly 20% intra quarter, the US market finished the quarter in positive territory. The Canadian market rose as the gold price remained firm over the period. In addition, Canada benefitted from inflows as investors diversified their holdings away from US assets.

In the US, sectors such technology and communication services led the market while defensive sectors such as utilities and consumer staples lagged the overall market as investors increased their risk exposure. In terms of country performance, the US market (SP500) outperformed the Canadian market (TSX) (in local currency terms).

Some of the better performing companies in the portfolio year to date include Singapore Tech Engineering's, Philip Morris, Telenor and Amphenol. Singapore Tech Engineering's outperformance was driven by strong 2024 fiscal year results, the company's Investor Day, and the narrative shift in global defence spending. The company reported better than expected margins and lifted the fourth quarter dividend per share. At the Investor Day, the company set out its targets to fiscal year 2029 and the outlook for all the main divisions was solid. This was set against a backdrop of surging defence spending, as the US pivots away from providing support to other nations.

Most of the outperformance from Telenor is due to investors rotating to defensive sectors. Telenor reported decent results for 2024 with some confidence from management that the company can deliver enough free cash flow in 2025 to cover the dividend. The dividend yield is currently still over 6%. Regulation in Norway is benign and so the stock is considered a relative 'safe haven' in the current market environment.

Amphenol rose as investors began to reinvest in the technology sector and the company posted strong results and gave an optimistic outlook regarding the impact of tariffs on the businesses. Philip Morris performed well as tobacco demand is resilient during periods of economic uncertainty and reported good results during the quarter. In addition, the company currently pays attractive dividends which adds to their investment appeal.

Companies that struggled over the 6 months were ASM Pacific Technology, T-Rowe Price and Lowe's. ASM Pacific reported weak results over the quarter. The company has continuing challenges in traditional assembly and packaging machine tools; however, they expect a second half of the year pick up. Additionally, they are still suffering a COVID hangover from big build out of capacity (inventory digestion) to meet chip shortages. The company remains excited about the opportunity in advanced packaging, which is growing strongly, and they remain well ahead of peers in TCBs having developed them over the last 13 years. Lowes remained weak as mortgage rates remained stubbornly high crimping housing demand and turnover, a key driver for the company. It is expected that mortgage rates will eventually fall, and this should benefit the company.

T Rowe Price was weak as investors remain concerned about the company fund flows which still need to stabilise. The company is also a proxy for the US equity market so when the US market is weak the stock price will reflect this. Lowes remained weak as mortgage rates remained stubbornly high crimping housing demand and turnover, a key driver for the company. It is expected that mortgage rates will eventually fall, and this should benefit the company.

Outlook

Pyrford retains a cautious outlook for international economic growth and expects the necessary adjustments to corporate and personal balance sheets in the developed West to take a prolonged period to achieve.

Following the rally in North American equity markets over the last few years, valuations are in aggregate less attractive than they were. Equity investors will be best rewarded by concentrating on high quality companies selling at low valuations relative to a defensive and visible stream of earnings. Financial leverage should be avoided, and investors should focus on companies which are very well capitalised and whose business models have proved resilient during previous periods of poor economic growth.

The last four years have seen equity market returns concentrated within a small number of US Technology companies. The 10 largest equities globally now account for 26% of the MSCI World Index, having accounted for less than 10% at the start of 2018. Of this rarefied group, 7 are in technology with the other 3 being Tesla, JP Morgan and Berkshire Hathway. This increasing concentration in tech stocks is the result of their exceptional performance, accounting for over 47-percentage points of the 125-percentage point increase in the MSCI World Index over the last 7 and a half years. Without them, the MSCI World Index would have risen only 78%. In other words, the next 1,490 companies in the MSCI World Index generated 8% annualised performance over the past 7.5 years with the largest 10 companies' contribution increasing overall index performance to 11.4%. If an investor has been fishing outside the top 10, keeping up has been hard, and is likely part of the reason actively managed funds have lost share to passive index funds over the past decade.

While we are keen to emphasise the heterogeneity of this select group they have typically benefitted from their dominance of high barrier to entry global markets with, critically, very low marginal costs and low capital intensity⁴. This has allowed them to grow whole dollar revenues at remarkable speed, and to previously hard to imagine scales. While much remains uncertain about AI, it is clear that large parts of the playing field are very different: highly contested markets with unclear moats and barriers to entry; extreme capital intensity particularly so relative to ill-defined and nascent revenue models; marginal costs to serve can be significant; the picks and shovels equipment providers are currently making all the money.

The continued outperformance of the mega-cap tech stocks is increasingly reliant on their ability to succeed in this new paradigm and for their investments in artificial intelligence (AI) and supporting infrastructure to continue to drive earnings. As these extremely well capitalised companies race to build their AI capabilities and fortify their moats, we have seen exponential growth in the "picks and shovels" providers to the AI industry, particularly semiconductors and their associated value chain. And yet, while it seems clear that AI will have a significant impact on humanity (rather like the internet) it is not clear what the winning combinations of sustainable competitive advantage and business model will be, and particularly so when one considers the super-normal returns required to justify the level of investment to date (never mind the ongoing investment).

We believe the current boom has the hallmarks of a "capital cycle". The closest analogy in terms of risk would be the internet bubble of the late 1990s when huge amounts of capital were deployed into the infrastructure of the internet (think routers, switches, fibre etc). This huge investment in optical networks proved to be a classic case of over-investment: by 2002 only a single-digit percentage of the capacity in North America and Europe was in use and the excess capacity was not fully absorbed until almost two decades later. Such low initial utilisation led to significant earnings declines and commensurately severe multiple downgrades.

The internet bubble is most vividly associated with the failure of concept stocks like Pets.com which lost paper wealth as quickly as they had created it. However, the true capital destruction was in the "picks and shovels" providers of the internet infrastructure and their customers, many of whom saw their share prices decline 80% or more (e.g. Nortel, Lucent, Ericsson etc). Indeed, at the peak of the bubble, three of the world's largest companies were beneficiaries of spending on the internet infrastructure (Cisco, Intel and Nokia). Their customers, the large telcos who were doing all the spending, didn't fare much better with their share prices often falling by two thirds or more (e.g. AT&T, Vodafone, Deutsche Telekom etc). Given the hype around the internet, these companies also became very large with NTT Docomo, Nippon Telegraph and Deutsche Telekom also in the top 10 global companies at the time.

To understand the impact of capital cycles on market concentration and returns, we have analysed the performance of the capitalisation weighted MSCI World Index against an equally weighted index of the same constituents. The analysis shows that the two indices produce broadly the same returns over the long run but with the market-cap weighted index significantly outperforming during periods of market euphoria and especially so when this is related to a new technology (the internet in the late 1990s and cloud / AI spend in the 2020s).

We believe these spells of out and underperformance are cyclical. In the years leading up to the NASDAQ bubble peak in 2000, the market-cap weighted index outperformed the equally weighted index by a cumulative 45 percentage points as large tech companies increasingly dominated the index and performance. In the ensuing bear market as the capital cycle turned down and the

internet bubble popped, the smaller index constituents which were much more exposed to the general economy significantly outperformed leading to 7 consecutive years of the equal weighted index outperforming the cap-weighted index (by a cumulative 81 percentage points).

Performance

The Global Equity Fund C Class returned +6.45% for the six months to the end of June 2025, compared to the MSCI World NR USD Index return of +9.47%.

The breakdown of attribution highlights a very straightforward narrative.

The Industrials overweight and stock selection contributed a + 5% relative performance, with the top 5 contributors all Industrial names, with heavy emphasis on aerospace -Airbus, Safran, Siemens, Vinci and Aena. Aena (airports) has now been sold on valuation.

The overweight and stock selection in Healthcare has cost the portfolio over the same period a -5% relative return, with United Health (UNH) the worst performer, but Becton Dickinson, BioRad and ThermoFisher also all falling in excess of 20%. The exposure to UNH has been significantly increased during this period.

Whilst these two sectors cancelled each other out, the swing into negative relative territory over the 6 month period, was a combination of the holding in Diageo and cash (which given the 10% rise in markets will have been a drag when looked at in isolation).

Large parts of the healthcare market are currently suffering from the lack of an AI narrative as well as significant post Covid headwinds including a destocking cycle, weaker government spending on healthcare and depressed demand from China. However as long-term investors we see significant potential for excellent absolute returns within this industry driven by the underlying trend of aging populations and the increased demand for healthcare as one ages. This positive tailwind together with the potential for significant competitive advantages within the industry (including scale, intellectual property, switching costs etc.) leads us to continue to have a large exposure to healthcare despite the short-term difficulties. Despite their often-exceptional values many of these companies are being largely ignored by momentum and shorter-term investors as their near-term performance has been occluded and they do not capture the current AI zeitgeist.

UNH is the leading US health insurer. It has diversified with its strongly growing Healthcare Services business Optum, which represents more than half of operating profit. As the largest insurer, UNH benefits from a number of competitive advantages. Over the long-term this should result in the company outperforming its competition, something that we have enjoyed over our holding period since September 2007. While the weight in the portfolio has changed over the intervening period, since that date UNH has delivered a total shareholder return of 661% (including the recent decline in share price) which equates to an annualised return of 12.2%. This return has largely been driven by earnings which grew by 509% over the period (or c.11% annualised) with the remaining return being generated by a 1.5% annual dividend. This total shareholder return compares very favourably with the MSCI World Index which over the same period (in USD) has delivered a total shareholder return of 283% (7.9% annually).

The company's competitive advantages can be summarized as scale and proprietary data:

- Scale in insurance here UNH has two advantages: 1) national scale and covered lives allows strong negotiating position with providers; 2) UNH leverages scale in its insurance business to test and scale Optum solutions and uses Optum solutions to drive lower costs of medical care in its insurance business. A virtuous circle.
- Scale in care delivery UNH owns much of its own care delivery including ambulatory care as well as the largest physician practice in the US. Again, the scale of UNH allows them to both acquire and fully utilise this resource to provide better quality care at lower cost than their competitors.
- Proprietary data UNH owns the leading healthcare IT solutions business (Optum Insight) and one of the largest Pharmacy Benefits Managers (Optum Rx) in the US. These businesses serve other health plans, corporates and the US Government and as a consequence UNH has a gigantic data set which it can analyse to provide insights into many facets of care to help provide both better services and to reduce costs.

While UNH's health insurance business has compounded revenues at 7.8% over the last 10 years, it is the Optum Health business that has driven revenue growth at 25% on the same metric. UNH, in Optum Health, has relentlessly amassed by far the largest primary care network in the US over the last 10 years. Optum now employs or is affiliated with >90,000 physicians, or c.18% of all primary physicians in the US. Such a footprint would be extremely difficult to replicate given the strength of regional health systems not to mention potential regulatory intervention. Revenue growth has been fuelled in the past 5 years by Optum Health

converting patients served into value-based arrangements from fee-for-service arrangements and the continued conversion of such patients – be they insured by UNH or over 90 other health insurers – is a key earnings growth driver of UNH for the next decade.

Outlook

Today, AI dominates the investment debate and yet it is far from clear what the winning business models will be, how much capital they will ultimately require (although it is seemingly a lot), what the returns will be on this capital and so, ultimately, what the impact will be on earnings. In this context, our approach is to identify those companies that have the greatest chances of durable and sustained success in this new paradigm while also being insulated from the significant risk that the fruits of the huge AI investment spend are either lower than currently anticipated (perhaps due to competition or the inability to have a competitive advantage) or are deferred much further into the future than many expect. Heads we win, tails we don't lose very much.

We believe Microsoft, Amazon and Alphabet (Google) are the franchises most likely to sustainably capture value and create durable recurring businesses in AI. These three holdings have significant core businesses that can be enhanced by AI and remain the bedrock of valuation. The outlook across the rest of the value chain is far less clear. For example, in a capacity constrained setting, chip makers are taking considerable price on their AI products (GPUs), a particularly risky strategy when the major buyers are starting to develop their own competing products. This doesn't tend to end well. Equally, while any pause or hiatus in CAPEX spending will have a deleterious impact on the semi-conductor value chain, our companies should see an inflection in free cash flow driven by their underlying core franchises and utilisation of their capacity.

The market's attention is drawn to powerful get rich quick narratives like a moth to a flame. During these periods of exuberance, those businesses that aren't seen to benefit get ignored and left behind. This is why market concentration is a cyclical phenomenon. While we are pleased to have some exposure to the AI theme, what we do have is consistent with our valuation discipline and absolute return mindset. That said, we suspect that the best opportunities today are those furthest away from the excitement, in areas like healthcare.

Performance

The Nedgroup Investments Global Flexible Fund ("the Fund" or "NGFF") gained 8.6% for the quarter and 11.9% for the trailing twelve months ("TTM"). The Fund captured 73.0% of the MSCI World's gain in the TTM, outperforming its own 60.3% average net risk exposure.⁵

With respect to the recent performance of the Fund, in the previous twelve months, the top five performers contributed 4.9% to its return while its bottom five detracted 1.7%.

Portfolio commentary

We continued to trim positions in 2024 and early 2025 in response to elevated valuations, resulting in increased cash as we await opportunities. After President Trump announced his Liberation Day tariffs on Thursday, April 2, 2025, global markets plunged, but just a few trading days later, they significantly rebounded. A stock market drawdown that lasts only a few days is too short a timeframe to materially shift the portfolio. Despite the brevity of the decline, we did selectively redeploy some capital in a few high-conviction positions.

Valuations remain above average, partly justified by lower-than-average interest rates. US companies continue to trade more expensively relative to their historical average and when compared to those based outside the US, which supports our continued interest in investing overseas.

When people become excited about market prospects, they tend to assume more risk, which can manifest in the form of paying a higher multiple, increasing risk exposure, or sometimes using leverage (e.g., through debt or derivatives). We see that happening today. This year is the second-largest inflow year into leveraged equities as of June 10th, and the year isn't over yet.⁶ Other speculative indicators help explain today's rising stock prices. Riskier option volumes have hit new highs (e.g., 0DTE).⁷ Retail investors have helped lead the charge, ramping up their investments in leveraged equity funds. Retail investors are also buying more stocks on margin (FINRA margin debt has more than doubled in the last five years).⁸

Broader risk-taking seems less appropriate given the elements of speculative excess combined with relatively high market valuations. NGFF continues to maintain a conservative posture, with risk assets ending the second quarter at 60.3%, down from 62.6% a year ago. The Fund's equity risk exposure has generally moved in inverse proportion to the market. When stock prices rise, exposure decreases, and conversely, when stock prices decline, exposure increases. This is a generalization, as sectors sometimes exhibit performances and valuations that deviate from the market as a whole. Before the recent market correction, the Fund's net equity exposure dropped to a recent low of 55.3%. We then purchased equities during the market weakness, which caused net equity exposure to increase moderately to 57.8% at quarter-end.

As far as funds go, NGFF utilizes an unusually wide range of tools and approaches to solve various problems effectively. We endeavour to avoid the cognitive bias of over-reliance on any one method. If it's raining, for example, we're looking for our umbrella, not our sunscreen.

Outlook

Nedgroup Investments Core Global Fund Class A increased by a return of 13.1% net of fees for the 12 months ended 30 June 2025; by comparison its performance indicator (Morningstar Europe OE USD Aggressive Allocation Category Average) increased by 9.8% over this period.

The Nedgroup Investments Core Global Fund was launched on the 16th of November 2015. The portfolio follows a long-term strategic asset allocation which is determined by Nedgroup Investments and implemented by BlackRock Investment Management (UK) who has been appointed as Sub-investment Manager. The portfolios' underlying holdings predominantly consist of iShares index mutual funds and ETFs, which are combined to gain efficient global exposure to a range of different asset classes (eg. equities, listed property, bonds, inflation-linked bonds and cash).

Market Commentary

The first half of 2025 stunned global markets, President Donald Trump declared a sweeping overhaul of U.S. trade that marked the most aggressive turn toward protectionism in nearly a century. The average U.S. import tariff surged from 2.5% to 24%, with most nations facing a flat 10% levy and strategic rivals hit even harder.

Markets reacted swiftly. Major indices tumbled on fears of a deepening trade war, slower global growth, and rising inflation. The scale and abruptness of the tariff regime sent shockwaves through supply chains and diplomatic circles alike. The global response remains a critical variable. China and the European Union, among others, hold significant leverage ranging from retaliatory tariffs to control over rare earth minerals vital to high-tech industries. Currency dynamics will also play a role: a stronger dollar could cushion inflationary effects, while tit-for-tat measures risk amplifying economic disruption.

Despite the turbulence, equity markets staged a remarkable comeback. The S&P 500 notched a record high by the end of June, fully recovering from an 18.8% drawdown in April. Global equities followed suit, with the MSCI All Country World Index climbing 11.7% for the quarter. Emerging markets led the charge, outperforming developed peers with a 12.2% gain.

This rebound was fuelled in part by easing geopolitical tensions. A brief but intense 12-day conflict between Israel and Iran in mid-June sent oil prices soaring above \$80 per barrel. However, a U.S.-brokered ceasefire helped stabilize the region, and crude prices eventually settled back to \$67.

Monetary policy responses varied across regions. The European Central Bank continued its easing trajectory, cutting interest rates by 25 basis points in June Tits eighth reduction in a year, totalling a 2% decline since mid-2024. The move reflects easing inflation and a cautiously improving economic outlook. In contrast, the Bank of England held rates steady at 4.25%, signalling a wait-and-see approach. Meanwhile, the People's Bank of China paused after a May rate cut, part of a broader effort to support a slowing economy amid trade headwinds.

Bond markets remained volatile, buffeted by geopolitical developments and concerns over U.S. fiscal health. A pending budget reconciliation bill raised alarms about long-term debt sustainability, keeping pressure on long-term yields. The Bloomberg Global Aggregate Bond Index still managed a 4.5% return for the quarter.

The U.S. dollar weakened notably, falling 7% against a basket of major currencies. Investor sentiment has been rattled by the Trump administration's aggressive policy shifts, and currency markets are adjusting accordingly.

Conclusion

The Core Global Fund's objective is to provide growth through low-cost exposure to a range of global asset classes. Diversification across asset classes, regions and currencies should help reduce risk and volatility to moderate levels. We believe that the combination of lower costs and broad diversification should benefit investors over long term and allow the portfolio to achieve its objective of capital growth over the medium to long term.

Performance

Nedgroup Investments Global Property Fund Class A gained 5.1% net of fees for the 6 months ended 30 June 2025; by comparison the performance indicator (FTSE EPRA/NAREIT Developed) added 6.1% over the same period. While Q1 saw modest underperformance, Q2's strong rebound, particularly in non-U.S. markets, lifted overall performance.

Key contributors included UK and European self-storage REITs, which benefited from improving operating dynamics. In the first quarter, Japanese developers, notably Sumitomo Realty & Development and Mitsui Fudosan, performed strongly amid activist investor engagement and supportive macro conditions. Finally, Healthcare REITs had a very strong period, especially in the U.S. led by the fund's largest position Welltower, which was driven by robust seniors housing demand and new funds management initiatives.

Conversely, performance was negatively impacted by U.S. retail REITs, such as Federal Realty, pressured by consumer strain and tariff concerns. Data centres faced volatility due to AI investment uncertainty and disappointing capital expenditure guidance from Equinix. Also detracting was exposure to Office REITs in the U.S., where leasing momentum remains uneven.

Portfolio adjustments included trimming exposure to economically sensitive sectors such as industrial and office, while increasing allocations to residential, healthcare, and diversified REITs in Japan, the UK, and Australia. The fund maintained a cautious stance on U.S. logistics and cold storage, both of which faced headwinds from rising vacancy and supply pressures.

Market Commentary

The first half of 2025 was marked by geopolitical tensions, shifting fiscal policies, and diverging central bank actions. The U.S. Federal Reserve held rates steady amid domestic policy uncertainty, while other major economies, including Europe and Canada, initiated rate cuts. This divergence supported REITs outside the U.S., particularly in Europe and Asia.

Currency movements, with a weaker U.S. Dollar, boosted returns in non-U.S. REIT markets. The period saw some M&A activity, especially in Europe and the UK, where listed REITs traded at significant discounts to NAV. Notable deals included Aedifica's acquisition of Cofinimmo and takeover proposals across logistics, healthcare, and student housing sectors.

Hong Kong's resurgence was driven by a sharp decline in HIBOR, increased Chinese listings, and stabilising residential and retail fundamentals.

The trend of Office market bifurcation continued, with prime assets in London and Manhattan showing strong demand, while subgrade properties struggled with financing and leasing.

The Retail real estate sector experienced a recovery, led by high-performing centres such as those owned by Unibail Rodamco Westfield, which also launched brand licensing initiatives to diversify revenue.

Sector performance varied widely. Data centres rebounded in Q2, but remained volatile due to capex concerns and questions over utilisation following the DeepSeek announcement in February. Healthcare continued to benefit from demographic tailwinds and limited new supply, showing strong growth in Funds From Operations (FFO).

In addition, Self-storage showed signs of recovery, particularly in the UK, despite acquisition-related concerns. Conversely, Industrial REITs faced pressure from trade policy uncertainty and oversupply.

ESG developments were notable in Japan, where new building codes mandate net-zero standards by 2030. Portfolio holdings Mitsui Fudosan and Sumitomo Realty are well-positioned to meet these requirements, having already implemented energy-efficient upgrades and renewable energy sourcing.

Outlook

Despite macroeconomic and geopolitical uncertainties, the outlook for global listed real estate remains constructive. REITs offer compelling value, trading at or below replacement cost, with strong balance sheets and moderate leverage. Operating fundamentals are sound, supported by:

Low vacancy rates, limited new supply due to high construction costs and financing constraints, and strong rental income growth potential, especially in sectors earning below-market rents

The fund expects net operating income growth to match or exceed inflation, assuming stable tenant demand. Risks include potential stagflation and prolonged economic slowdown, particularly in sectors with longer lease durations like office and industrial. However, the portfolio is underweight in these areas and focused on segments with resilient, needs-based demand.

Commercial real estate transaction volumes remain subdued but are expected to rise as loan maturities approach, aiding price discovery and capital recycling. Increased deal activity should support REIT valuations and performance.

In a world of heightened volatility, REITs continue to offer liquidity, transparency, and income backed by tangible assets. The fund remains positioned to capture upside from quality real estate platforms with pricing power and disciplined capital management.

With respect to the recent performance of the Fund, in the previous twelve months, NCVE's top five performers contributed 9.5% to its return while its bottom five detracted 3.7%.

Among the top performers were Holcim and Amrize. The companies performed well on the back of strong business performance and a strategic decision to separate the company's North American operations. The North American operations have taken the name Amrize and have a U.S. listing (NYSE: AMRZ). We are pleased to see former CEO Jan Jenisch return to lead the North American business. Among the detractors was International Flavors & Fragrances. The company strengthened its balance sheet through a series of asset sales. Since the beginning of 2024, new management has consistently delivered or exceeded financial targets. Despite these positive developments, the company's shares have re-rated lower, and the stock price has declined.

The Fund added four investments – Hoshizaki, Thermo Fisher, Vipshop, Amrize (from Holcim spinoff) – and increased five during the quarter – Comcast, TE Connectivity, Analog Devices, ICON, and Fortune Brands. The Fund decreased positions in Citigroup, Holcim, Kinder Morgan, Meta, Nexon, and Wells Fargo. The Fund did not exit any positions during the quarter.

There were 48 equity positions in the Fund with the top five holdings comprising 25.9% and the top 10 comprising 43.7% of the portfolio (based on total assets) as of end June. The top three sector exposures in the Fund, based on the Global Industry Classification Standard (GICS) sector classification, are Communication Services, Industrials, and Consumer Discretionary which comprise 48.1% of the total assets of the Fund. As a percentage of equity, the Fund has 44.2% non-US exposure and 55.8% exposure in the US. However, 56.2% (as a percentage of equity) of the portfolio companies' revenues are non-US.¹¹

After President Trump announced his Liberation Day tariffs on Thursday, April 2, 2025, global markets plunged, but just a few trading days later, they significantly rebounded. A stock market drawdown that lasts only a few days is too short a timeframe to materially shift the portfolio. Despite the brevity of the decline, we did selectively reallocate some capital in a few high-conviction positions.

Valuations remain above average, partly justified by lower-than-average interest rates. US companies continue to trade more expensively relative to their historical average and when compared to those based outside the US, which supports our continued interest in investing overseas.

When people become excited about market prospects, they tend to assume more risk, which can manifest in the form of paying a higher multiple, increasing risk exposure, or sometimes using leverage (e.g., through debt or derivatives). We see that happening today. This year is the second-largest inflow year into leveraged equities as of June 10th, and the year isn't over yet. ¹² Other speculative indicators help explain today's rising stock prices. Riskier option volumes have hit new highs (e.g., 0DTE). ¹³ Retail investors have helped lead the charge, ramping up their investments in leveraged equity funds. Retail investors are also buying more stocks on margin (FINRA margin debt has more than doubled in the last five years). ¹⁴ Broader risk-taking seems less appropriate given the elements of speculative excess combined with relatively high market valuations.

Market Commentary

Emerging markets were boosted by a falling dollar as the MSCI EM Index returned +15.6%. In Taiwan, markets whipsawed from the "DeepSeek shock" in January hitting investor confidence in AI infrastructure names, before a roaring recovery in the second quarter. In South Korea there was a strong rally in beaten down Value-Up beneficiaries.

The falling US dollar supported liquidity sensitive Hong Kong exposure. Rallying mainland stocks in China was also a positive contributor. Like Taiwan, stock picking in India has been one of the stronger contributors over the past few years but had a pullback over this period. Negative tariff headlines hit Southeast Asia. Saudi Arabia was weaker as the conflict between Israel and Iran intensified.

Performance

Emerging markets were boosted by a falling dollar as the Fund (USD D Class) returned +12.6% against a surging MSCI EM Index up +15.6%.

Exposure in Taiwan was a detractor as the revelation of DeepSeek's AI innovation triggered selling of AI supply chain companies. Deepseek's AI models demonstrated that you don't have to invest huge amounts of money and hardware to build powerful AI. While the majority of our tech names bounced back in the second half, it was not enough to keep pace with the broader market. AI supply chain names Lotes (-22.5%) and Ememory (-20.3%) struggled over period, while TSMC (11.7%) and Aspeed (62.0%) fared much better. In our view, TSMC's resilience reflects the likelihood that DeepSeek will not change demand for the most advanced chips running at the lowest possible power. TSMC's dominance in leading-edge production remains a competitive moat. Aspeed (61.9%) is a producer of server management chips and reported rapid sales growth underpinned by AI server demand. We expect demand for AI infrastructure to persist as AI applications evolve from reactive, limited chat functions requiring clear inputs and producing limited outputs, to autonomous assistants able to complete tasks. Despite the bright story we are not throwing caution to the wind. DeepSeek's R1 AI model raises questions over whether software innovation will dent infrastructure demand, while a falling USD will pressure exporters. Our approach is to focus exposure on companies dominating leading edge hardware while avoiding commoditised segments lacking moats and pricing power to mitigate against currency volatility.

Our companies in South Korea trailed a huge market rally, boosted by hopes for president Lee Jae-Myung's election platform of corporate governance reforms. Lee's Democratic Party are also supporters of the Value-up Program introduced under president Yoon. Market authorities aim to use the initiative to pressure companies into improving governance, returns, and drive higher valuations. The biggest beneficiaries of Value-Up will be some of the poorest quality companies, with sub-par returns and often management that is not looking out for the interests of minority shareholders. Our stock selection approach of seeking out companies that deliver high and improving returns on invested capital, driven by outstanding management teams who know how to allocate capital means that we are very selective when investing in this thematic. We have been able to find a few names that fit our process, and which helped us to keep pace with the rally. Our position in Samsung Life rose 46.6% on expectations reforms will force disposal of company holdings in affiliated companies. Samsung Life selling its position in Samsung Electronics would trigger a huge one-off gain freeing up cash to be re-deployed productively. We trimmed Samsung Life to rotate into laggard DB Insurance, which is cheaper and, in our view, has greater upside catalysts, being yet to announce Value-up plans. Leading bank KB Financial was another contributor, reporting robust profit growth with a surprise share buyback and cancellation as well as a higher dividend. KB also looks set to benefit from planned fiscal loosening by the Lee government and falling central bank rates boosting loan growth.

Contributions from exposure in Hong Kong and mainland China were strong with both markets supported by a positive liquidity backdrop. Chifeng Gold Mining led domestic holdings, along with contributions from China Merchants Bank and Alibaba. We reduced mainland exposure in favour of Hong Kong over the period. Modest fiscal stimulus on the mainland has been fading, while liquidity is surging in Hong Kong as its Monetary Authority intervenes against a falling USD to maintain the HKD-USD peg, causing rates to plunge. The monetary boost supported a rally in Hong Kong Exchanges and Clearing (HKEX), AIA and Prudential. The current environment looks encouraging for HKEX, which reported that a record 208 companies applied for a listing in the year to end-June. A-to-H share listings have been a demand driver, and our investment in Chifeng is an example. Earlier this year we were fortunate to have met their entrepreneurial and ambitious management team before being invited to participate in the Chifeng H-share IPO at a discount, with proceeds to be used as funding for deals outside China. We ultimately made a large trim to the position as it doubled within a few months of purchase.

Greek and Polish equities surged on the back of rising sentiment for European equities driven by fiscal expansion in Germany. While overweight positioning was a positive as both markets rallied during the period, this was offset by underperformance in Polish consumer names and not owning the Greek banks. Polish fashion retailer LPP was the main laggard with margins under pressure from an aggressive store rollout plan, as operating expenditures climb on hiring costs. However, in our talks with LPP, management confirmed that they will scale back the rollout, especially among smaller stores, which will benefit margins. LPP should benefit from healthy consumer demand supported by the Polish government's loose fiscal footing. The strong economy and relatively high rates are also a boost for holding Bank Pekao's profitability, trading on 1.25x book with a 23% ROE.

Contributions from stock picking across rallying markets in Latin America were strong. In Brazil, high end jewellery chain Vivara, water utility SABESP and property developer Cyrela outperformed. Agribusiness lender Banco do Brasil was the largest detractor, reporting poor results including rising loan delinquencies. We exited the stock on a view that weak agricultural prices have taken a bigger toll on the sector than first thought. Strength in Brazilian equities belies a macro backdrop souring on president Lula's fiscal profligacy. Our contrarian take is that Brazil's economic malaise presents an opportunity in that it makes Lula's re-election unlikely.

A conservative victory in the 2026 federal elections could usher in an era of fiscal responsibility, likely a huge upside catalyst for stocks trading at cheap valuations. In Mexico we moved to zero weight by exiting high ROE bank Banorte. While the bank's performance has been robust, we expect loan growth to slow. However, what is more concerning is Mexico's deteriorating institutional quality following president Sheinbaum's pursuit of judicial reform culminating in the election of judges across the country in June. The regressive vote strengthens the ruling Morena party's grip over what was a relatively independent judiciary. During the period we added to Argentina, Hong Kong and Malaysia, and reduced Mexico, Greece, and China.

Outlook

President Trump's desire to reduce the US trade deficit has important implications for financial markets. If the US trade deficit shrinks, then the need for foreign capital to finance imports falls. Less foreign demand for USD assets should boost weak EM currencies and under-owned equities which have faced the headwind of a strong dollar.

Things start to break when the dollar reaches such extremes, and whether it be through the market mechanism or politics, reversion eventually occurs. President Nixon ended dollar- gold convertibility in 1971, and slapped tariffs on the rest of the world in response to rising balance of payments pressures. The Plaza Accord under President Reagan in the 1980s was an attempt to rebalance trade through currency intervention. The dollar fell hard in both cases.

There are echoes of these interventions in today's "Trump shock", and if this includes a shift to a weak dollar regime we could see a cycle of EM reflation. An EM currency tailwind will bring about easing credit conditions feeding into economic and corporate earnings growth, attracting capital flows. If this virtuous circle takes shape, we believe that understanding the reflexive linkages that currencies, money and credit have with company fundamentals will be crucial in navigating a new market regime.

Nedgroup Investments Global Strategic Bond Fund

What we said six months ago

- 1. The global impact of Trump's policy agenda was already a key concern; tariffs would likely trigger stagflationary pressures and delay rate cuts.
- 2. With core G7 bond yields sitting above current and expected inflation, global bonds offer investors long-term value. However, yield curves remained stubbornly flat, reinforcing our preference for short-duration bonds, which we expected to outperform.
- 3. Credit markets remain resilient, but valuations were stretched. As macro risks built, we anticipated a gradual widening of spreads through the year.
- 4. Fundamentals remained solid, but elevated valuations demanded a selective approach. We emphasised credit selection, as markets were increasingly reactive to earnings volatility and M&A activity.

What happened in H1 2025

Net returns (US\$): Fund 4.37%, Index: 2.81%

The first half of 2025 delivered positive returns for global bonds and our portfolio. While volatility remained elevated, it was largely range-bound—creating fertile ground for active, value-driven managers like us. Our global approach allowed us to capitalise on dislocations across geography, the curve and credit names.

Credit markets entered 2025 with stretched valuations — particularly in US Investment Grade — and consensus expected spread widening. Instead, February saw spreads compress to pre-GFC levels, driven by strong technicals: robust inflows (especially into short-dated high yield) and subdued net supply. We used this strength to reduce exposure by cutting 10% from BBB-rated credit and 10% from overall credit holdings.

Trump's "Liberation Day" tariff announcements triggered a brief bout of spread widening in early April. Our value-driven process prompted us to re-enter selectively, adding to corporate hybrids and other higher-yielding segments. This proved timely, as credit markets rebounded strongly. Economic data surprised to the upside, and the anticipated Q1 slowdown failed to materialise. By mid-May, spreads had retraced much of their widening as Trump scaled back parts of his tariff plans.

Market's absorbed macro shocks without significant, sustained repricing, reflecting both strong demand, as all in yields continued to attract buyers, and a healthy corporate backdrop. Fundamentals remained intact, with stable leverage metrics and successful refinancing across sectors. M&A activity, which we had expected to return, remained subdued amid corporate uncertainty. Capital investment was delayed in tariff affected sectors, whilst utilities advanced, supported by robust free cash flow and limited tariff exposure.

While tariffs initially dominated macro risk, attention shifted to the Middle East as tensions escalated. A tentative ceasefire between Iran and Israel helped stabilise oil prices, which had threatened to derail Trump's economic agenda. Meanwhile, progress on US trade negotiations with both the EU and China reduced the tail risk of a full-blown trade war.

The short-term impact of tariffs on growth and inflation remained front and centre. In the US, a drop in immigration lowered the breakeven for job growth, making softer payrolls more tolerable. In Europe, macro fundamentals were more supportive, with the ECB retaining greater flexibility to cut rates. The euro's appreciation may help contain inflation into 2026, even as Germany embarks on a transformative fiscal expansion.

These dynamics created short-term volatility and cross market opportunity. US Treasuries underperformed early in the year, while Bunds later came under pressure as Germany signalled increased issuance to fund defence spending. Supportive technicals — both strong inflows and light positioning — helped drive prices higher. Our barbell strategy of combining defensive carry with enhanced yield from short-dated high yield, delivered steady returns.

Tying all that together, our ability to navigate the market noise while maintaining discipline in our value-driven approach enabled us to quickly adapt to shifting macro and political dynamics and deliver steady returns.

Rates Outlook

Trump came in hard, markets pushed back harder. Equities sold off, bond yields surged and oil spiked. That sets the scene for H2. The more tariffs are rolled back, the greater the chance the US escapes stagflation. We may have more clarity by late July, but we're not betting on it. Trump appears to favour a weaker dollar—importing inflation to the US while exporting disinflation to the rest of the G7. If oil stabilises, that could help ease headline CPI globally. But the path of US Treasuries remains the anchor: where they go, G7 yields tend to follow. That said, a softer dollar tilts our preference toward European duration. EU bonds look relatively more attractive than US Treasuries in this setup. The actual impact of protectionist policy—on growth, inflation, and capital flows—will be the key driver of relative performance across Treasuries, Bunds, Gilts, and even JGBs.

Rates Outlook (continued\)

Markets are increasingly pricing in divergent rate paths across the G7. Japan still looks set to hike, the ECB may manage a single cut, while the US, UK, and Australia have multiple reductions priced in. This divergence breeds opportunity. We remain zero-weighted to Japan, slightly underweight US duration, and modestly overweight the rest of the G7, where we see better relative value. Since portfolio launch, interest rate curves have steepened materially. Markets are now trading near long-term fair value. In the US, the curve's slope suggests a high probability of recession—but we're not convinced that should be the base case. The rise in long-end yields seems less about imminent economic contraction and more a reflection of structural imbalances: persistent budget deficits and a burgeoning debt to GDP ratio.

Credit Outlook

A tentative ceasefire between Iran and Isreal combined with a pullback from the most extreme tariff scenarios, has allowed credit markets to price in significantly lower tail risks. Solid credit fundamentals, strong balance sheets and lower rates, suggest spreads will continue to trade in a narrow, expensive range. However, with a growing list of geopolitical risks and any further signs of deterioration in economic activity, credit remains vulnerable to the kind of sharp repricing witnessed in early April. Earnings visibility remains unclear, particularly as the impact of tariffs on pulling forward demand, is unknown. As a result, we maintain our bias towards defensive sectors such as utilities and telcos to anchor returns and complement this with selective exposure to short-dated higher yielding credit offering decent excess yield. Within financials, our positioning is dominated by senior global bank bonds and supplemented by an allocation to short dated lower Tier 2 bonds.

With summer issuance expected to slow and flows into European credit remaining resilient, we continue to see a more favourable technical backdrop in Europe relative to the US. Fundamentally, our greatest concern lies with the health of the US consumer as tariffs begin to bite, and the labour market weakens. While we do have exposure to the US auto sector, it is concentrated in short-dated paper offering decent carry. High yield issuance has been lower than anticipated due to a sharp decline in corporate activity amid tariff uncertainty. This technical support has helped the market, and we expect it to continue. Valuations do not support a meaningful allocation to high yield as they continue to price in little economic deterioration. Furthermore, we do expect an uptick in fallen angels – companies downgraded to high yield – for the first time in a while. We have, therefore, adopted a barbell approach adding further to our short-dated high yield exposure but credit selection is key.

NOTES TO THE FINANCIAL STATEMENTS FOR THE FINANCIAL PERIOD ENDED 30 JUNE 2025

1. General Information

Structure

The reporting entity, Nedgroup Investments Funds plc (the "Company") is an umbrella fund with segregated liability between Sub-Funds (the "Sub-Funds") established as an open-ended investment Company with variable capital. The Company was incorporated as a public limited liability company, in the Isle of Man on 28 January 1999. It was redomiciled into Ireland on 13 May 2014, under the laws of Ireland as a public limited company, pursuant to the Companies Act 2014 and the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations, 2011, as amended (the "UCITS Regulations") and the Central Bank (Supervision and Enforcement) Act 2013 (Section 48(1)) (Undertakings for Collective Investment in Transferable Securities) Regulations 2019 (the "Central Bank UCITS Regulations"), and has been authorised by the Central Bank as an Undertakings for Collective Investment in Transferable Securities ("UCITS"). Its share capital is divided into a number of classes each representing interests in a Sub-Fund and each Sub-Fund may comprise various classes of shares. The subscriber shares do not entitle the holders to participate in the assets of any of the Sub-Funds.

Investment Objectives of the Sub-Funds

Global Cautious Fund

The investment objective of the Global Cautious Fund is to achieve, over a longer-term horizon, higher returns than those available from money market instruments denominated in US Dollars. More specifically, this Sub-Fund will aim to generate a return above cash as measured by the US Dollar one month SOFR over a rolling three-year period with volatility below that of equities.

Global Equity Fund

The investment objective of the Global Equity Fund is to build capital over a number of years through investment in a focused portfolio of global companies.

Global Flexible Fund

The investment objective of the Global Flexible Fund is to provide investors with long-term capital growth.

Core Global Fund

The investment objective of the Core Global Fund is to provide capital growth through low cost exposure to a range of global asset classes. Diversification across asset classes will help to reduce risk and volatility to moderate levels over the medium to longer term.

Global Property Fund

The investment objective of the Global Property Fund is to achieve an annual total return that exceeds the total return of the FTSE EPRA/NAREIT Developed Index NET TRI (Benchmark) after fees measured on a rolling three year basis. The Benchmark is designed to track the performance of listed real estate companies and REITs worldwide, but the management of the Sub-Fund is not constrained by the Benchmark. In order to pursue its objective the Sub-Fund will employ an active management approach.

Contrarian Value Equity Fund

The investment objective of the Contrarian Value Equity Fund is to provide investors with long term capital growth.

Global Emerging Markets Equity Fund

The investment objective of the Global Emerging Markets Equity Fund is to provide investors with long term capital growth through investment primarily in equity and equity related securities issued by companies domiciled in or whose principal business activities are conducted in emerging market countries with no particular industry or geographical focus.

The Sub-Fund may also invest from time to time on an opportunistic basis in countries which are considered as frontier or developed markets to a maximum of 15% in aggregate.

Global Strategic Bond Fund

The investment objective of the Sub-Fund is to provide a combination of capital growth and income over the long term by investing in global bonds.

2. Significant Accounting Policies

The condensed interim financial statements for the six months ended 30 June 2025 have been prepared in accordance with International Financial Reporting Standards ("IFRS"), Interim Financial Reporting and should be read in conjunction with the 31 December 2024 annual report and audited financial statements. These condensed interim financial statements were prepared on the same basis of accounting policies set out therein.

3. Balances Due from/to Broker

Margin accounts represent cash deposits with brokers, transferred as collateral against open derivative contracts. The Sub-Funds may use brokers to transact derivative transactions, including those with central counterparties.

In accordance with the Company's policy of trade-date accounting for regular-way sale and purchase transactions, sale/purchase transactions awaiting settlement represent amounts receivable/payable to securities sold/purchased but not yet settled as at the reporting date.

Balances due from and to broker for each of the Sub-Funds as at 30 June 2025 and 31 December 2024 are detailed in the Statement of Financial Position.

4. Taxation

Under current law and practice, the Company qualifies as an investment undertaking as defined in Section 739B of the Taxes Consolidation Act, 1997, as amended. On this basis, it is generally not chargeable to Irish tax on its income or gains.

However, Irish tax can arise on the happening of a "chargeable event" in the Company. A chargeable event includes any payments of distributions to shareholders, any encashment, repurchase, redemption, cancellation or transfer of shares and any deemed disposal of shares as described below for Irish tax purposes arising as a result of holding shares in the Company for a period of eight years or more. Where a chargeable event occurs, the Company is required to account for the Irish tax thereon.

No Irish tax will arise on the Company in respect of chargeable events where:

- (a) a shareholder who is not Irish resident nor ordinarily resident in Ireland at the time of the chargeable event, provided the necessary signed statutory declarations are held by the Company; or
- (b) certain exempted Irish resident investors who have provided the Company with the necessary signed statutory declarations; or
- (c) any transactions in relation to shares held in a recognised clearing system as designated by order of the Revenue Commissioners of Ireland; or
- (d) an exchange of shares representing one Sub-Fund for another Sub-Fund of the Company; or
- (e) an exchange of shares arising on a qualifying amalgamation or reconstruction of the Company with another company; or
- (f) certain exchanges of shares between spouses and former spouses.

In the absence of an appropriate declaration, the Company will be liable to Irish tax on the occurrence of a chargeable event.

Dividends, interest and capital gains (if any) received on investments made by the Company may be subject to withholding taxes imposed by the country of origin and such taxes may not be recoverable by the Company or its shareholders.

The Sub-Funds currently incur withholding taxes imposed on investment income. Such income are recorded gross of withholding taxes in the Statement of Comprehensive Income. Withholding taxes are shown as a separate item in the Statement of Comprehensive Income. Withholding tax expense incurred by the Company during the financial period amounted to USD 5,653,977 (30 June 2024: USD 4,446,067).

5. Connected Person and Related Party Transactions

Connected Person Transactions

Regulation 43 of the Central Bank UCITS Regulations "restrictions on transactions with connected persons" states that "a responsible person shall ensure that any transaction between a UCITS and a connected person is conducted a) at arm's length; and b) in the best interest of the unitholders of the UCITS".

As required under UCITS Regulation 81(4), the Directors of the Manager, as responsible persons are satisfied that there are in place arrangements, evidenced by written procedures, to ensure that the obligations that are prescribed by UCITS Regulation 43(1) are applied to all transactions with a connected person; and all transactions with a connected person that were entered into during the financial period to which the report relates complied with the obligations that are prescribed by UCITS Regulation 43(1).

Investment Management and Distribution Fees

Nedgroup Investments (IOM) Limited is the Investment Manager and Distributor of the Company. Nedgroup Investment (IOM) Limited also hold 99 subscriber shares. Fees paid to Investment Manager and Distribution is disclosed in Note 8.

As at financial period ended 30 June 2025 and financial year ended 31 December 2024, 100 subscriber shares of USD 0.01 each were in issue. These subscriber shares were issued for the purposes of the incorporation of the Company, and are legally and beneficially owned by Tracey Wiltcher and Nedgroup Investments (IOM) Limited. The subscriber shares do not form part of the Net Asset Value of the Company and are thus disclosed in the financial statement by way of this note only.

Directors' fees and expenses for the financial period amounted to USD 32,094 (30 June 2024: USD 28,670) with USD 7,517 payable as at the financial period end (31 December 2024: USD 9,222).

6. Share Capital

The authorised share capital of the Company is 100 subscriber shares of USD 0.01 each and 1,000,000,000,000 shares of no par value initially designated as unclassified shares.

The subscriber shares do not entitle the holders to participate in the dividends or net assets of any Sub-Funds except when the Company winds up, in which case, the subscriber shares are entitled to the payment of sums up to the notional amount paid thereon out of the assets of the Company not attributable to any class of Share. In the event that there are insufficient assets to enable such payment in full to be made, no recourse shall be had to the assets of the Company attributable to other classes of shares.

Within each Sub-Fund and Class, the Company may issue participating shares which shall represent interests in the same distinct portfolio of investments. The net income per Distributing participating shares will be distributed in accordance with the dividend policy for the Sub-Fund as set out in the relevant Supplement and may be in the form of additional Shares to Shareholders. No declarations or distributions shall be made in respect of the Accumulating participating shares. Any net income attributable to the Accumulating participating shares shall be retained and the value of such Shares will rise accordingly.

7. Cash and cash equivalents

All cash and cash equivalents are held with Citibank N.A. in the name of Citi Depositary Services Ireland Designated Activity Company as Depositary. Citi Depositary Services Ireland Designated Activity Company credit rating as at 30 June 2025 was A+ (31 December 2024: A+) (Ratings Source: Standard & Poor's).

Cash and cash equivalents held by each of the Sub-Funds as at 30 June 2025 and 31 December 2024 are detailed in the Statement of Financial Position.

8. Fees and Expenses

Manager Fees

The Manager shall be paid a fee out of the assets of the Sub-Fund, calculated and accrued on each Dealing Day and payable monthly in arrears, of an amount up to 0.01% of the Net Asset Value of the Sub-Fund (plus VAT, if any), subject to a monthly minimum fee up to 0.01% (plus VAT, if any).

The Manager shall also be entitled to be reimbursed for its reasonable out-of-pocket expenses, payable out of the assets of the Sub-Fund (with value added tax thereon, if applicable).

Investment Management and Distribution Fees

The Company pays to the Investment Manager monthly Investment management and distribution fees. The amount of the Investment management and distribution fees for each Sub-Fund is set out below and is expressed as a percentage per annum of the relevant Sub-Fund's Net Asset Value.

The Investment Manager is also entitled to be reimbursed out of the assets of each Sub-Fund for all its own reasonable out-of-pocket costs and expenses. The Investment Manager is responsible for the payment of the fees of any sub-investment manager.

Total investment management and distribution fees during the financial period amounted to USD 25,095,171 (30 June 2024: USD 24,180,712) with USD 4,098,468 payable as at financial period end (31 December 2024: USD 4,261,911).

Administration Fee

The Administrator is paid an administration fee, calculated and accrued on each dealing day and payable monthly in arrears out of the assets of each Sub-Fund as per the below table:

Administration fees during the financial period amounted to USD 1,819,795 (30 June 2024: USD 1,006,260) with USD 531,686 payable as at financial period end (31 December 2024: USD 489,711).

The Administrator is also entitled to be reimbursed by the Company for all reasonable out-of-pocket expenses incurred by it.

Depositary Fees

The Depositary receives from the Company a fee, calculated and accrued on each dealing day and payable monthly in arrears, at the rate of up to 2.30 basis points of the Net Asset Value of each Sub-Fund, subject to a minimum fee of USD 15,000 per annum/USD 1,250 per Sub-Fund per month.

The Company will also reimburse the Depositary for transaction charges at normal commercial rates and for reasonable out-of-pocket expenses necessarily incurred in the performance of its duties.

Total Depositary fees during the financial period amounted to USD 1,009,132 (30 June 2024: USD 826,465) with USD 250,428 payable as at financial period end (31 December 2024: USD 227,287).

Operating Expenses

The Company is responsible for all normal operating expenses including audit fees and charges incurred on the acquisition and realisation of investments. General operating expenses, which are not allocable to a specific Sub-Fund, are evenly split across the Sub-Funds or split based on the value of each Sub-Fund, as applicable.

Total Expense Cap

The aggregate expenses of each Sub-Fund payable out of the assets of the Sub-Fund will not exceed 1% per annum of the Net Asset Value of each Sub-Fund. This will include any fees and expenses payable to each of the Administrator, the Depositary and all other fees and expenses as specified in the Prospectus. It does not include the fees of the Investment Manager or the fees of the underlying investment funds.

9. Distributions

The Directors intend to declare and pay dividends on a quarterly basis for the Global Property Fund and Global Strategic Bond Fund from the net investment income of Class D USD Income shares.

10. Financial Risk Management

The investment process and other related activities expose the Company to a variety of financial risks, as mentioned in the Prospectus and Supplements. Generally, risk management is a structured approach to managing uncertainty. It comprises a sequence of activities including: risk assessment(risk measurement and monitoring), strategies developed to manage it, mitigation of risk using managerial resource and using the commitment approach to calculate global exposure.

The main recognised risk areas are: Market Risk; Credit Risk; Liquidity Risk; Operational Risk and the Calculation of Global Exposure.

a) Market Risk

Market risk is the risk of loss arising from movements in market variables including observable variables such as interest rates, exchange rates and others that may be indirectly observable such as volatilities and correlations. The risk of price movements on securities and other obligations in tradable form resulting from risk factors and events specific to individual issuers is also considered market risk.

Market risk is comprised of three main types of risk: Price Risk, Currency Risk and Interest Rate Risk. The concentration of market risk by type of investment is disclosed in more detail in the Schedule of Investments.

a) Market Risk (continued)

i) Price Risk

The Sub-Funds' portfolios are exposed to market price risk. Market price risk is the risk that the value of investment holdings will fluctuate as a result of changes in market prices caused by factors specific to the security or factors affecting all securities traded in the market. These risks are monitored by the Sub-Investment Managers in pursuance of the investment objectives and policies of the Sub-Funds. Adherence to investment guidelines mitigates the risk of excessive exposure to any particular type of security or issuer.

ii) Currency Risk

The Sub-Funds can be exposed to currency risk as a result of investing in assets denominated in currencies other than the base currency of the Sub-Fund. Where the Sub-Investment Managers deem it necessary, this exposure to foreign currency fluctuations is mitigated by the use of OTC forward foreign currency exchange contracts.

The Sub-Funds can also be exposed to indirect foreign currency risk where it is investing in assets which have underlying exposure to foreign currency, for example funds which in turn invest in foreign currency denominated assets. Foreign exchange risk is an on-going consideration during the asset allocation and investment selection process.

During the financial period, OTC forward foreign currency exchange contracts were entered into for the purpose of share class hedging. The notional amounts are detailed in the Schedule of Investments.

iii) Interest Rate Risk

The Sub-Funds can be exposed to interest rate risk through holding debt securities and cash. Bond yields (and as a consequence bond prices) are determined by market perception as to the appropriate level of yields given the economic background. Interest rate risk is examined by the Sub-Investment Managers using an internal monitoring system. The risk can be reduced by diversifying (investing in funds who invest in fixed income securities with different durations). The Sub-Investment Managers review on a regular basis the values of fixed interest rate securities in underlying investments.

b) Credit Risk

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. This includes counterparty risk and issuer risk. The Sub-Funds hold cash and cash deposits, which potentially expose the Sub-Funds to counterparty risk. The Sub-Funds also hold short-term debtors in the form of unsettled subscription amounts, unsettled securities sold, outstanding coupon and dividend amounts. The risk from these is deemed to be low. Investments are spread across a large number of investment management houses. Investment management reviews are frequently conducted and limits are also set on the amount that may be due from any one manager. The carrying amounts of financial assets best represent the maximum credit risk exposure at the Statement of Financial Position date.

This relates also to financial assets carried at amortised cost, as they have a short-term to maturity. Substantially all of the assets of the Sub-Funds are held by Citi Depositary Services Ireland Designated Activity Company. As such, there is a concentration of credit risk with Citi Depositary Services Ireland Designated Activity Company. Bankruptcy or insolvency of the Depositary may cause the Sub-Funds' rights with respect to securities held by the Depositary to be delayed or limited. The Sub-Funds will be treated as a general creditor in respect of cash held.

Balances due from broker represent margin accounts and sales transactions awaiting settlement. Credit risk relating to unsettled transactions is considered small due to the short settlement period involved and the high credit quality of the brokers used.

The Sub-Funds' credit risk is monitored by monitoring the credit quality and financial position of the Depositary the Sub-Funds use.

c) Liquidity Risk

This is the risk that the Company will encounter difficulty in meeting obligations associated with financial liabilities. The Company is subject to cash redemptions of redeemable participating shares on each dealing day of the respective Sub-Fund. The dealing days are detailed in the Supplements to the Prospectus. It therefore invests the majority of its assets in investments that are traded in an active market and can be readily disposed of. The Sub-Funds' underlying investments are considered readily realisable.

c) Liquidity Risk (continued)

The Core Global Fund invests in iShares' funds and Investment Funds managed by BlackRock Asset Management Ireland Limited as at 30 June 2025. The Global Emerging Markets Equity Fund also invests in an Investment Fund managed by Enterprise Investment Managers Ltd. Liquidity risk of these funds arises from the redemption requests of investors and the liquidity of the underlying investments the funds are invested in. The shareholders of these funds may redeem their shares on the close of any daily dealing deadline for cash equal to a proportionate share of the Funds' NAV.

The Sub-Funds are therefore potentially exposed to the liquidity risk of meeting the shareholders' redemptions and may need to sell assets at prevailing market prices to meet liquidity demands. As a shareholder in these funds, the Core Global Fund and the Global Emerging Markets Equity Fund are also exposed to the liquidity risk of these funds. The Directors may at their discretion limit the number of shares of any Sub-Fund redeemed on any dealing day to' shares representing 10% or more of the outstanding shares in any Sub-Fund or shares representing 10% or more of the total Net Asset Value of that Sub-Fund on that dealing day. In this event, the limitation will apply pro rata so that all shareholders wishing to have shares of that Sub-Fund redeemed on that Dealing Day realise the same proportion of such shares. Shares not redeemed, but which would otherwise have been redeemed, will be carried forward for redemption on the next dealing day (subject always to the foregoing limit).

d) Operational Risk

Operational risk is the risk of direct or indirect loss, arising from a wide variety of causes associated with the processes, technology and infrastructure supporting the Company's activities with financial instruments, either internally within the Company or externally at the Company's service providers and from external factors other than credit, market and liquidity risks such as those arising from legal and regulatory requirements and generally accepted standards of investment management behaviour.

The Company's objective is to manage operational risk, so as to balance the limiting of financial losses and damage to its reputation with achieving its investment objective of generating returns to investors.

The primary responsibility for the development and implementation of controls over operational risk rests with the Board of Directors. This responsibility is supported by the development of overall standards for the management of operational risk, which encompasses the controls and processes at the service providers and the establishment of service levels with the service providers.

The Directors' assessment of the adequacy of the controls and processes in place at the service providers with respect to operational risk is carried out via regular discussions with the service providers.

e) Calculation of Global Exposure

The global exposure of the assets held within each Sub-Fund is monitored on a daily basis. In accordance with the regulatory requirements, global exposure can be calculated in two ways, either;

- (1) the incremental exposure generated by the instruments held by a Sub-Fund ("the commitment approach"); or
- (2) where complex investment strategies are used, an advanced risk management methodology such as Value at Risk ("VaR") will be employed.

The Sub-Investment Managers will monitor the assets of each Sub-Fund to ensure that global exposure and leverage will, at all times, remain within the limits set by the Central Bank. The commitment approach is used to calculate global exposure on all Sub-Funds in operation at 30 June 2025.

In accordance with the commitment approach, global exposure is broadly defined as the total market value of the equivalent underlying to all of the financial derivative instruments ("FDIs") entered into by a Sub-Fund (subject to all specific valuation rules described in the European Securities and Markets Authority guidelines).

f) Concentration Risk

As the assets of the Sub-Funds may be invested in a limited number of investments which may be concentrated in a few industries, sectors of the economy or issuers, the negative impact on the value of the assets of the sub funds from adverse movements in a particular economy or industry or in the value of securities of a particular issuer could be considerably greater than if the sub funds were not permitted to concentrate its investments to such an extent.

Concentrations of risk are disclosed in some detail in the Schedules of Investments of each Sub-Fund.

11. Fair Value of Financial Assets and Financial Liabilities

This requires the Sub-Funds to classify fair value measurements using a fair value hierarchy that reflects the significance of the inputs used in making the measurements. The three levels of the fair value hierarchy are described below:

- Level 1: Quoted prices (unadjusted) in active markets for identical securities.
- **Level 2:** Prices determined using significant observable inputs. Observable inputs are inputs that reflect the assumptions market participants would use in pricing a security and are developed based on market data obtained from sources independent of the reporting entity (including quoted prices for similar investments, interest rates, prepayment speeds, credit risk, etc.).
- Level 3: Prices determined using significant unobservable inputs. In situations where quoted prices or observable inputs are unavailable or deemed less relevant (for example, when there is little or no market activity for an investment at the end of the financial period), unobservable inputs are inputs that reflect the reporting entity's own assumptions about the factors market participants would use in pricing the security and would be based on the best information available under the circumstances.

The inputs or methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities. The level in the fair value hierarchy within which the fair value measurement is categorised in its entirety is determined on the basis of the lowest level input that is significant to the fair value measurement in its entirety. For this purpose, the significance of an input is assessed against the fair value measurement in its entirety.

Assessing the significance of a particular input to the fair value measurement in its entirety requires judgement, considering factors specific to the asset or liability. The determination of what constitutes "observable" requires significant judgement. The Directors consider observable data to be that market data that is readily available, regularly distributed or updated, reliable and verifiable, not proprietary and provided by independent sources that are actively involved in the relevant market.

Other than financial assets at fair value through profit or loss and financial liabilities at fair value through profit or loss, all other financial instruments not measured at fair value through profit or loss are short-term financial assets and financial liabilities whose carrying amounts approximate fair value. In accordance with IFRS 13, these financial assets and financial liabilities are classified as Level 2 apart from deposits with credit institutions, which are classified as Level 1.

IFRS 12 defines a structured entity as an entity that has been designed so that voting or similar rights are not the dominant factor in deciding who controls the entity, such as when any voting rights relate to the administrative tasks only and the relevant activities are directed by means of contractual agreements. Disclosures are required where an interest is held in a structured entity and where, for example, the investor has been involved in the setting up of the structured entity and the investor would have exposure to potential losses or costs over and above the amount actually invested.

The amount of the Net Asset Value of a Sub-Fund attributable to a class shall be determined by establishing the value of shares in issue in the class and by allocating relevant fees and expenses to that class and making appropriate adjustments to take account of distributions paid out of the Sub-Fund, if applicable, and apportioning the Net Asset Value of the Sub-Fund accordingly.

The Net Asset Value per share of a class shall be calculated by dividing the Net Asset Value of the class by the number of shares in issue in that class. The value of the assets of a Sub-Fund shall be determined in the base currency of the Sub-Fund.

These services may include, for example, research and analysis of the relative merits of individual shares or markets or the use of computer and other information facilities. In return, the sub-investment manager will place a proportion of business with these brokers including transactions relating to the Sub-Funds' investments. The sub-investment manager considers these arrangements to be to the benefit of the Company and have satisfied themselves that they each obtain best execution on behalf of the Company and the brokerage rates are not in excess of customarily institutional full service brokerage rates. Research Payments

Included in other expenses for the Global Emerging Markets Equity Fund is an amount of USD 64,967 (31 December 2024: USD 72,684) for research fees paid and payable to the Sub-Investment Manager to buy research. This is part of an annual budget agreed with the Sub-Investment Manager allowable under MiFID rules and administered by way of a Research Payment Account. The budget for 2025 is USD 100,431 (31 December 2024: USD 81,862). The Global Emerging Markets Equity Fund is the only Sub-Fund operating such an arrangement.

Commitments and Contingent Liabilities

As at the Statement of Financial Position date, the Company had no commitments or contingent liabilities (31 December 2024: Nil).

Securities Financing Transactions Regulation (SFTR) (EU 2015/2365)

During the financial period ended 30 June 2025, the Sub-Funds did not enter into any transaction that requires disclosure under the Securities Financing Transaction Regulation.

Efficient Portfolio Management

Subject to the conditions and within the limits from time to time laid down by the Central Bank, and except as otherwise stated in the investment objective and policies of the Sub-Funds, the Sub-Investment Managers may employ, for certain Sub-Funds, investment techniques and instruments such as future contracts, options, OTC forward foreign currency exchange contracts and other derivatives for efficient portfolio management purposes. Furthermore, new techniques and instruments may be developed which may be suitable for use by a Sub-Fund in the future, and a Sub-Fund may employ such techniques and instruments subject to the prior approval of, and any restrictions imposed by, the Central Bank.

For UCITS which have invested in FDIs and/or engaged in efficient portfolio management techniques, disclosures are required under UCITS Regulation 79(1). The Sub-Investment Managers of the Sub-Funds have identified all FDIs, which are OTC forward foreign currency exchange contracts and future contracts. The notional amounts are detailed in the Schedule of Investments.

Global Cautious Fund

The Sub-Fund may employ FDIs comprising equity index future contracts, fixed income future contracts, OTC forward foreign currency exchange contracts, equity options and fixed income options as described in the Prospectus for the efficient portfolio management of the Sub-Fund and for hedging purposes, within the limits laid down by the Central Bank. The Global Cautious Fund used OTC forward foreign currency exchange contracts during the financial period.
