Investor profile

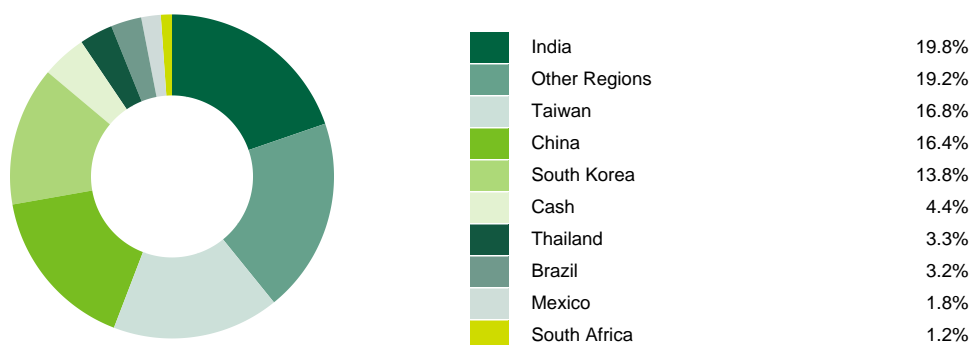
