

### Investor profile

The portfolio is suitable for investors seeking low cost global exposure to a range of asset classes as as part of their overall investment strategy, with capital appreciation as their primary goal and who do not wish to make complex asset allocation decisions between equities, cash and bonds in global markets. Investors should have a high tolerance for short-term market volatility in order to achieve long-term objectives.

The Sub-Investment Manager will select collective investment schemes that seek to replicate, as closely as possible, the constituents of the relevant benchmark index, and will do so by holding similar proportions of all of the securities comprising the benchmark index. 
