The Sub-Fund is actively managed and is not managed in reference to any benchmark.

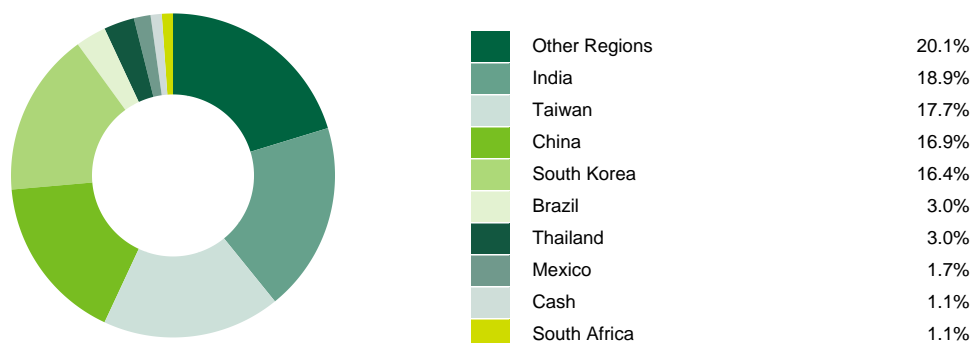
