





Portfolio structure




Geographic diversification



Consistency relative to peers over different rolling periods



Definitions

Bloomberg Global Aggregate Bond Index for foreign bond, Bloomberg Global ILB Index for foreign inflation linked bonds and Composite USD/GBP/EUR Libor for foreign cash.
