- Single position size is limited to the higher of 10% or 110% of the weight within the FTSE/JSE Basic Materials index.






About the fund manager

Investment philosophy


- Long-term investors by nature, their investment philosophy is to search for companies on attractive valuations relative to peers.

Portfolio structure


