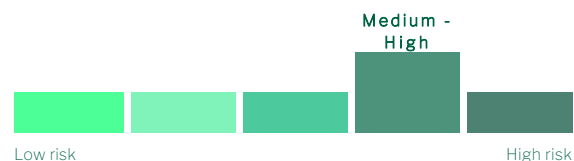

Investment objectives

- The portfolio seeks to balance real capital growth and income objectives through a blended allocation to risk assets and income yielding assets.

- The fund is suitable for investors who require specific exposure to both local and offshore assets, in a balanced manner, as part of their overall investment strategy.



Investment policy

- Our portfolios contain a foundation of quality assets.
- These are complemented by satellite investments that together aim to achieve defined, risk-managed investment outcomes for our clients.
- Equity exposure is limited to a maximum of 75% which helps reduce risk and volatility.
- The fund may also include international exposure on a limited and select basis and may also invest in participatory interests in portfolios of collective investment schemes.

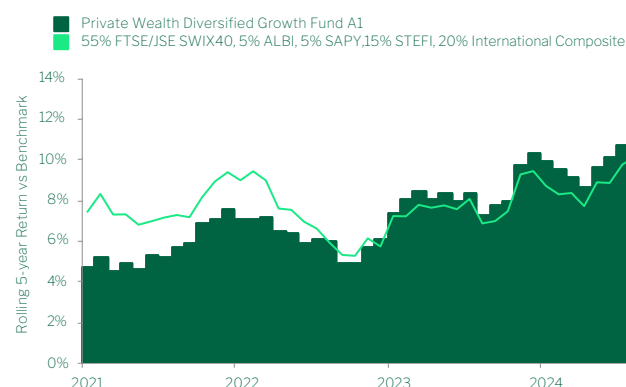


Fund related risks

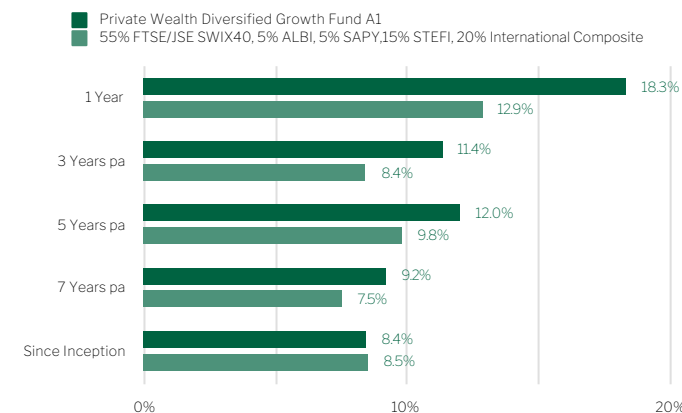

▶ Nedbank Private Wealth's investment philosophy is defined as: long-term, well considered.

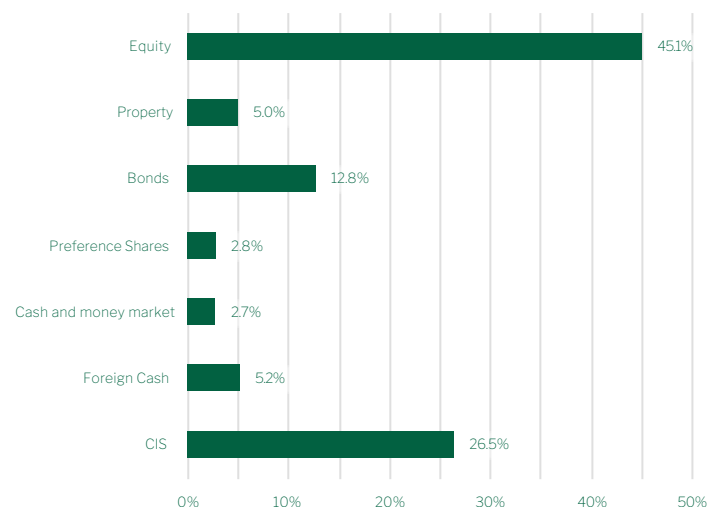
▶ The process is built on making an assessment of the quality of an investment and paying a fair price by being valuation focused.

▶ Nedbank Private Wealth focuses on evaluating earnings growth, dividend growth and the potential change in valuation rating of a business.

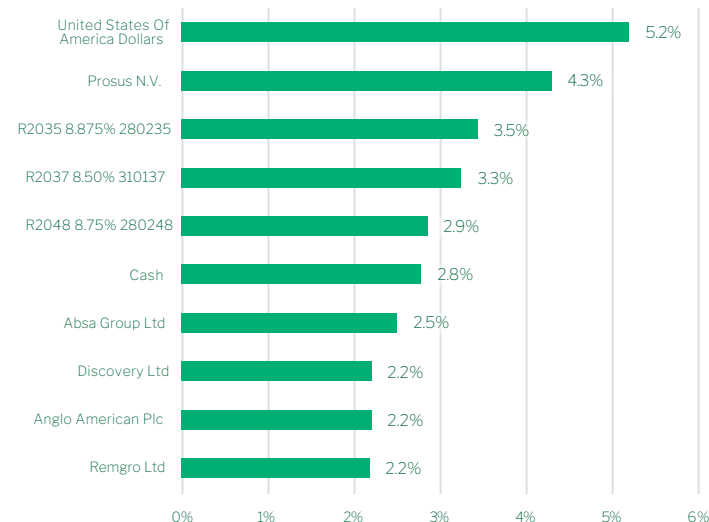
▶ They also have a strong focus on risk management, which is managed by position size and ensuring appropriate diversification.

Portfolio structure

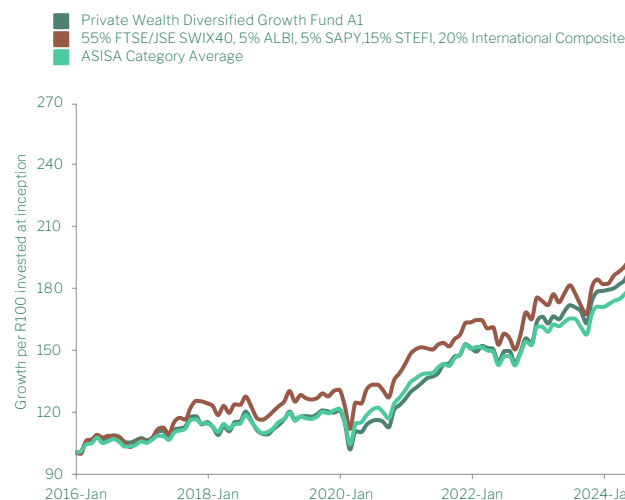
