

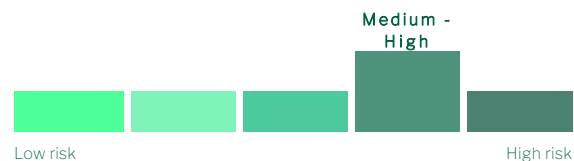

- Derivative financial instruments are permitted.

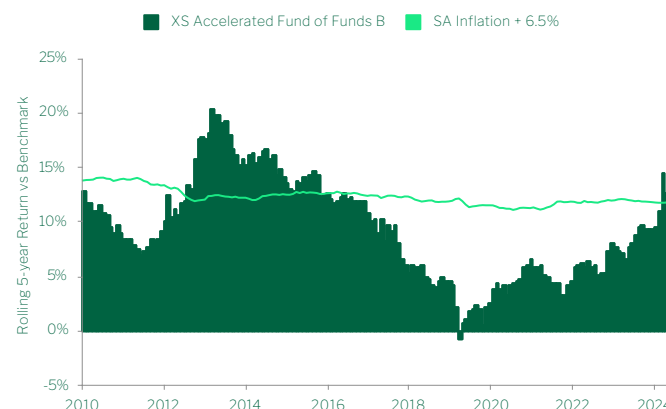

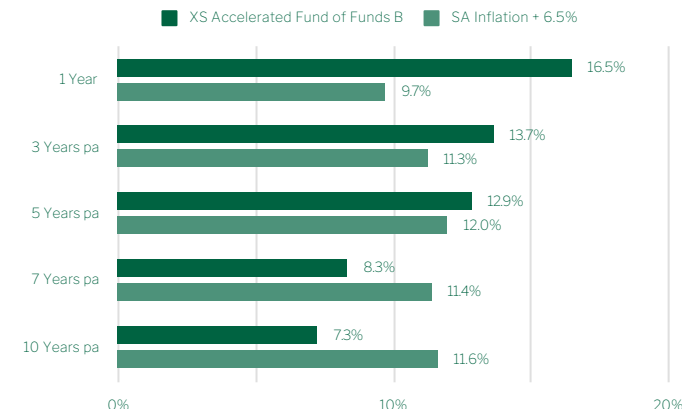

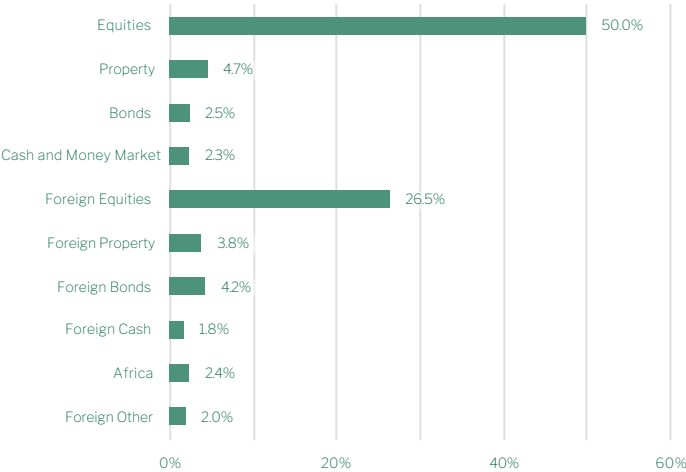

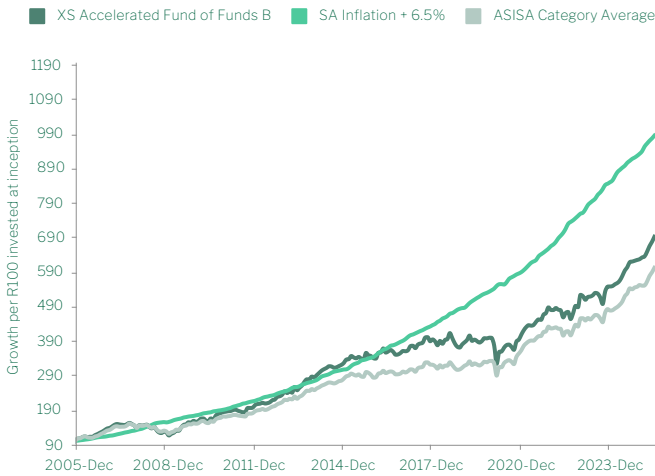

### Definitions
