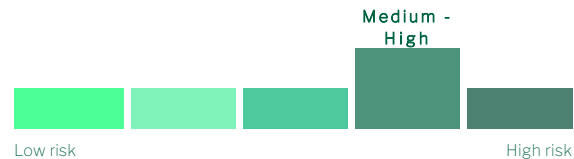

- Derivative financial instruments are permitted.

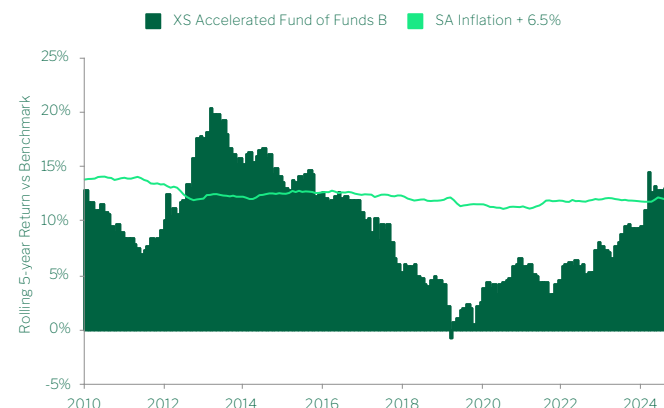

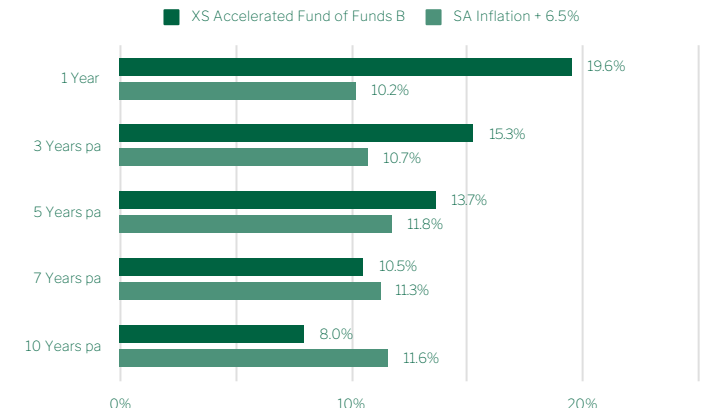

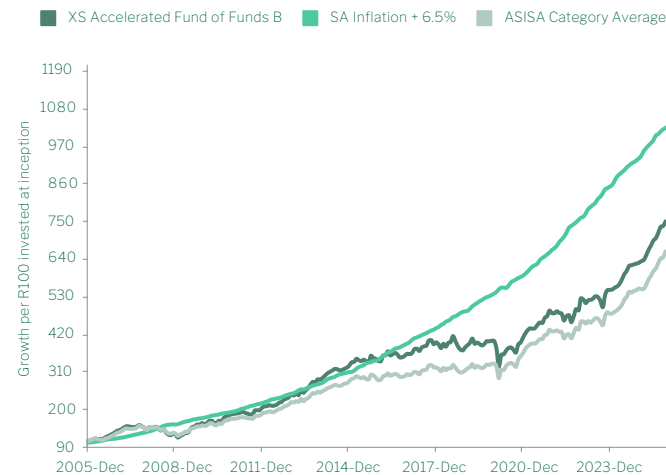

Definitions
